- Work with cycling industry companies, organizations (such as Clubs, Teams and Youth Programs) and the media to grow the sport of cycling in Wisconsin and ensure sustainability in women's cycling for the future.
- Nurture the interest and support the development of amateur women by partnering with grassroots programs and facilitating mentorship for junior and developing riders.
- Increase the breadth and depth of media coverage in Wisconsin of women's cycling and the sport of cycling in general.

Wisconsin Women's Fund Grant Process Guidelines

Grant Application Process - Guidelines for Consideration

Our **Guidelines for Consideration** include but are not limited to the following checklist.

- Your organization **MUST** provide a copy of your IRS tax-exempt classification under the IRS Code section 501(c)3 or provide written proof of a formal affiliation with a not-for-profit, tax-exempt 501(c)3 organization.
- Your organization must be organized in and located within the State of Wisconsin.
- Goals must be measurable and set in advance as part of the application process.
- Your organization will not use funds toward general operating expenses.
- Your organization will not use funds toward staff salaries.
- Your organization will not use funds for any political campaign or movement.
- Your program or project must directly benefit girls and/or women in the State of Wisconsin.
- Your program or project must be consistent with the Wisconsin Women's Fund's mission and funding priorities.
- Awarded funds may only be utilized for stated purpose as outlined in an approved grant application.
- Awarded recipients must provide quarterly updates and a year-end final report. The final report, including receipts of expenditures, is to be submitted no later than one-year past distribution of funds.
- Any unused funds must be returned to the Wisconsin Women's Fund, Inc. at the end of the grant period.
- Grant applications that include an element of matching will be given priority. Match could include volunteer time, in-kind donations, or cash match. Volunteerism could include helping at events benefitting Wi Women's Fund.
- Attendance at Power of the Pedal award banquet is required, though grant recipients will not be required to purchase a ticket.
- Including photos of participants at your activities as part of the quarterly report is strongly encouraged.
- Recipients will acknowledge the benefits the funding had on their program or project on social media, including statements like "[activity] was made possible through a Wi Women's Fund grant award." We ask social media postings and websites use these hashtags #WomenRideWomenLead @WiWomensFund and our logo.

Wisconsin Women's Fund Grant Application Process & Timelines

- The portal will be open and accepting Grant Applications on July 12, 2018.
- Funds awarded through this grant process will be distributed no later than December 31, 2018.
- **Deadline** for submitting complete grant proposals is October 5, 2018.
- Be prepared to answer questions that may arise during the final grant review process.
- Those awarded grant funding will be expected to participate in a check presentation photo and press release.

Grant Period

When funds are awarded, your organization has a 12-month grant period to use and report their use. Funds may cover your program or project budget in full or as a portion of your budget. The grant period had a duration spanning no more than a 12-month period, including evaluation and reporting.

Grant Recipient Reporting Deadline

Within 30 days after the end date of your program or project or at one-year past distribution of funds, whichever comes first, due are...

- your use of funds report, including copies of your receipts.
- a summary of the impact the funds had on your program or project.
- photos and/or social media links
- the return of any unused funds to Wisconsin Women's Fund, Inc.

Grant Application

Decision Making Criteria: The following **Criteria** will be used in the decision-making process. Make sure your **written application** addresses these criteria.

- You agree to the *Guidelines for Consideration* (page 2) and *Grant Application Process & Timelines* (page 3).
- Is the request designed for the unique needs of Girls and Women in Wisconsin?
- Does the project or program address a gap in services or an emerging need?
- Have you clearly identified your target market and how many people are directly and indirectly impacted?
- Have you outlined a realistic timeline and implementation strategy?
- Are there evaluation and measurements tools in place?

Written Application: Provide us with a written application that includes the following information.

- Project Summary: Include evidence of need
 - How is this project new and innovative?
 - What gap in services does this project address?

III. Attach Supporting Articles:

- IRS Letter indicating your 501(c)3 tax-exempt status
- Other supporting documents: Project Summary, Budgets, Timelines, etc.
